#### REPORT OF ACTION OF THE 2001 COUNCIL ON LEGISLATION OF ROTARY INTERNATIONAL

To all Rotary clubs:

The Council on Legislation of Rotary International met 21-27 April 2001 in Chicago, Illinois, USA. In accordance with section 8.130.2. of the bylaws of RI, this is a report to all clubs of the action taken by the Council in adopting 98 items of legislation.

The Council considered 631 items of proposed legislation. These included 388 proposed enactments (proposals to amend the constitutional documents of RI) and 243 proposed resolutions (proposals which do not seek to amend the constitutional documents of RI). The Council adopted 55 enactments and 43 resolutions. Three items were referred to the Board of Directors of RI for further study. The Council rejected 301 proposals. 227 proposals were withdrawn or considered withdrawn. (Note: Two of the withdrawn proposals were incorporated into a similar proposal which was adopted.) Two proposals were tabled. Of the 98 adopted proposals, 90 were adopted by the Council exactly as they were proposed, while eight were adopted with amendments. Those adopted with amendments are noted within the report by an asterisk (\*) after the number of the proposal. You will note that, where necessitated by amendments, the titles of the proposals have been changed to accurately reflect the final intent of the legislation.

The legislation contained in this report is presented in the format used by the Council. It illustrates changes to the current constitutional documents of RI by underlining new text and lining though deleted text.

As you study these items of legislation, please bear in mind that each piece of legislation must stand alone as it was adopted. Each adopted enactment was drafted to achieve its individual purpose by amending the constitutional documents as they currently exist. All overlapping and correlative changes will be made in the production of the 2001 *Manual of Procedure*.

At the end of this report is an "Opposition to Legislation Report Form." After carefully studying each individual item in this book, any club, in accordance with section 8.130.3. of the RI bylaws, may use this form to record its opposition to any adopted enactment or resolution. Completed forms **must** reach the World Headquarters of RI in Evanston by **20 August 2001**. If by that time, clubs representing ten or more percent of the total number of votes entitled to be cast by all clubs have filed forms regarding their opposition to any item of legislation adopted by the Council, that item will be considered suspended. The General Secretary will then prepare and distribute a ballot to each club within one month of the suspension. The ballot will submit the question of whether the action of the Council should be sustained in regard to the suspended item of legislation. The ballot will be conducted according to the provisions of sections 8.130.5., 8.130.6. and 8.130.7. of the RI bylaws. Based on the results of the ballot, the suspended item will either be nullified or reinstated.

Please note that a club should complete and return the form at the end of this report to the General Secretary <u>only</u> if it wishes to oppose some action by the Council. If a club does not wish to oppose an action of the 2001 Council on Legislation, no action is required.

#### **ADOPTED ENACTMENT 01-04**

To allow the club board to cancel up to four regular meetings in a year and allow the cancellation of not more than three consecutive meetings

IT IS ENACTED by Rotary International that the STANDARD ROTARY CLUB CONSTITUTION be and hereby is amended as follows (page 253 MOP)

#### Article IV Meetings

#### Section 1 —

.3 If a regular meeting falls on a legal holiday or in case of the death of the club president, or of an epidemic or of a disaster affecting the whole community, the board may cancel such regular meeting. The board of directors of this club, at its discretion, may cancel not more than twofour regular meetings in any one Rotary year for causes not otherwise specified herein provided always that the club should not fail to meet for more than twothree consecutive meetings.

#### **ADOPTED ENACTMENT 01-16**

To allow the cancellation of a regular meeting due to the death of a club member

IT IS ENACTED by Rotary International that the STANDARD ROTARY CLUB CONSTITUTION be and hereby is amended as follows (page 253 MOP)

# Article IV Meetings

Section 1 —

.3 If a regular meeting falls on a legal holiday or in case of the death of the <u>a</u> club <u>member president</u>, or of an epidemic or of a disaster affecting the whole community, the board may cancel such regular meeting. The board of directors of this club, at its discretion, may cancel not more than two regular meetings in any one Rotary year for causes not otherwise specified herein provided always that the club should not fail to meet for more than two consecutive meetings.

# **ADOPTED ENACTMENT 01-25**

To provide that the club board may notify a member that failure to attend four consecutive meetings might be considered a request to terminate membership

IT IS ENACTED by Rotary International that the STANDARD ROTARY CLUB CONSTITUTION be and hereby is amended as follows (page 260 MOP)

#### Article X Duration of Membership

**Section 5** — *Termination* — *Non-Attendance*.

- (a) Each member, other than an honorary member of this club, must
  - (1) attend or make up at least sixty percent of club regular meetings in each half of the Rotary year;
  - (2) attend at least thirty percent of the regular meetings of this club in each half of the Rotary year.

If such a member fails to attend as required above, that person's membership shall automatically terminate unless the board consents to such non-attendance for good and sufficient reason. If such member is a current officer of RI, that member shall be excused from attending the regular meetings of such member's club until the member's current term of office expires.

(b) The membership of any member, other than an honorary member, of this club shall automatically terminate if, without the consent of the board for good and sufficient reason, the member fails to attend or make up four consecutive club meetings. Each member of this club, other than an honorary member, who fails to attend or make up four consecutive club meetings, shall be informed by the board that his/her non-attendance might be considered as a request to terminate membership in the club.

# **ADOPTED ENACTMENT 01-26**

To remove the automatic termination provisions for failing to attend 60% of regular meetings

IT IS ENACTED by Rotary International that the STANDARD ROTARY CLUB CONSTITUTION be and hereby is amended as follows (page 260 MOP)

# Article X Duration of Membership

**Section 5** — *Termination* — *Non-Attendance*.

- (a) Each member, other than an honorary member of this club, must
  - (1) attend or make up at least sixty percent of club regular meetings in each half of the Rotary year;
  - (2) attend at least thirty percent of the regular meetings of this club in each half of the Rotary year.

If such a member fails to attend as required above, that person's membership shall automatically terminate <u>be subject to termination</u> unless the board consents to such non-attendance for good and sufficient reason. If such member is a current officer of RI, that member shall be excused from attending the regular meetings of such member's club until the member's current term of office expires.

(b) The membership of any member, other than an honorary member, of this club shall automatically terminate <u>be subject to termination</u> if, without the consent of the board for good and sufficient reason, the member fails to attend or make up four consecutive club meetings.

#### ADOPTED ENACTMENT 01-38

To allow attendance credit for a member who attends less than 60% of a regular meeting when the member is unexpectedly called away from a meeting

IT IS ENACTED by Rotary International that the STANDARD ROTARY CLUB CONSTITUTION be and hereby is amended as follows (page 256 MOP)

#### Article VII Attendance

Section 1 — Every member of this club should attend its regular meetings. A member shall be counted as attending a regular meeting of this club if such member is present for at least 60% of the time devoted for the regular meeting, or is present and is called away unexpectedly and subsequently produces evidence to the satisfaction of the board of this club that such action was reasonable, or makes up for an absence in any of the following ways:

# ADOPTED ENACTMENT 01-39

To allow attendance credit for attending a club-sponsored community event or meeting or a club board or service committee meeting

IT IS ENACTED by Rotary International that the STANDARD ROTARY CLUB CONSTITUTION be and hereby is amended as follows (page 257 MOP)

#### Article VII Attendance

- Section 1 Every member of this club should attend its regular meetings. A member shall be counted as attending a regular meeting of this club if such member is present for at least 60% of the time devoted for the regular meeting or makes up for an absence in any of the following ways:
  - (a) If at any time within 14 days before or after the usual time for that meeting such member
    - (vi) attends <u>and participates in a club service project or a club sponsored</u> <u>community event or meeting</u> authorized by the board of this club;
    - (vii) attends a board of directors' meeting of this club or, if authorized by the board, a meeting of a service committee to which such member is assigned.

# ADOPTED ENACTMENT 01-51

To allow attendance credit for attending various meetings

IT IS ENACTED by Rotary International that the STANDARD ROTARY CLUB CONSTITUTION be and hereby is amended as follows (page 257 MOP)

#### Article VII Attendance

- Section 1 Every member of this club should attend its regular meetings. A member shall be counted as attending a regular meeting of this club if such member is present for at least 60 percent of the time devoted for the regular meeting or makes up for an absence in any of the following ways:
  - (a) If at any time within 14 days before or after the usual time for that meeting such member
    - (ii) by direction of this club, attends a regular meeting of a Rotaract or Interact club or Rotary Village Corps or of a provisional Rotaract or Interact club or Rotary Village Corps, or

#### ADOPTED ENACTMENT 01-76\*

To allow the club board to determine the conditions and circumstances under which a member's absence may be excused

IT IS ENACTED by Rotary International that the STANDARD ROTARY CLUB CONSTITUTION be and hereby is amended as follows (pages 256-258 MOP)

#### Article VII Attendance

- Section 1 Every member of this club should attend its regular meetings. A member shall be counted as attending a regular meeting of this club if such member is present for at least 60% of the time devoted for the regular meeting or makes up for an absence in any of the following ways:
  - (a) If at any time within 14 days before or after the usual time for that meeting such member
    - (i) attends at least 60% of the time devoted for the regular meeting of another club or of a provisional club, or
    - (ii) by direction of this club, attends a regular meeting of a Rotaract or Interact club or Rotary Village Corps or of a provisional Rotaract or Interact club or Rotary Village Corps, or
    - (iii) attends a convention of RI, a council on legislation, an international assembly, a Rotary institute for past and present officers of RI, a Rotary institute for past, present, and incoming officers of RI, or any other meeting convened with the approval of the board, the president acting for the board of RI, a Rotary multizone conference, a RI committee meeting, a Rotary district conference, a Rotary district assembly, any district meeting held by direction of the board of directors of RI, any district committee meeting held by direction of the district governor, or a regularly announced intercity meeting of Rotary clubs, or
    - (iv) is present at the usual time and place of a regular meeting of another club for the purpose of attending such meeting, and that club is not meeting at the time and place, or

- (v) except that where a member is traveling outside the member's country of residence for a period exceeding fourteen days, the time restriction shall not be imposed by this subsection inasmuch as a member may attend meetings in another country at any time during the period of travel, and each such attendance shall count as a valid make-up for any regular meeting missed at this club during the member's time abroad, or
- (vi) attends a club service project authorized by the board of this club.
- (b) If, at the time of such meeting, a member is
  - (i) traveling with reasonable directness to or from one of the meetings mentioned in paragraph (a) (iii) of this section, or
  - (ii) on Rotary business serving as an officer or member of a committee of RI, or a trustee of The Rotary Foundation, or
  - (iii) on Rotary business serving as the special representative of the district governor in the formation of a new club, or
  - (iv) on Rotary business in the employ of RI, or
  - (v) directly and actively engaged in a district-sponsored or a RI or Rotary Foundation-sponsored service project in a remote area where the opportunity for making up attendance is completely impossible, or
  - (vi) engaged in Rotary business duly authorized by the board of this club if this precludes attendance at a meeting of this club, or
  - (vii) working in bona fide circumstances within the member's own country of residence for extended periods on outposted assignments when, by mutual agreement between the member's home club and a nominated club, the member may attend such nominated club for the period of assignment, validated by an appropriate form of advice by the secretary of said club to the member's home club where such attendance shall be credited in the member's name.
- Section 2 Notice of Make-up. In the cases set out in subsection (a) (ii), (a) (iii) or subsection (b) of section 1 of this article, the member shall only be counted as being in attendance if notice of the fact is given by the member personally to the club. In the cases set out in subparagraphs (a) (i) and (iv), such notice may be given by the member personally or by the secretary of the club visited.

Section 32 — Exemptions. A member's absence shall be excused if

- (i) the absence is caused by protracted ill health or impairment or by stay of more than two weeks in a country in which Rotary clubs do not exist so that such member is physically unable to attend a regular meeting and the board approves such absence.
  - (ii) In the case of intended absence in a country in which there are no Rotary clubs, the member shall inform the secretary of this club before starting the journey or, if that is impossible, in writing from that country. Before approving such absence, the board shall satisfy itself that the journey will prevent the member from making up an absence in accordance with section 1 (a) of this article, or
- (a) the absence complies with the conditions and under circumstances approved by the club board. The club board is empowered to excuse a member's absence for reasons which it considers to be good and sufficient.

- (b) a member is a senior active member and the aggregate of the member's years of age and years of membership in one or more clubs is 85 years or more and the member has notified the club secretary in writing of the member's desire to be excused from attendance and the board has approved.
- (b) the aggregate of the member's years of age and years of membership in one or more clubs is 85 years or more and the member has notified the club secretary in writing of the member's desire to be excused from attendance and the board has approved.

The absences of members who fall into categories (a) (i) and (ii) above and whose absences have been excused shall not be included in the club's attendance records for the period in question. Members who fall into category (b) above shall not be included in the membership figure used to compute the club's attendance; further, neither their absences nor attendances shall be used for that purpose.

# **ADOPTED RESOLUTION 01-111\***

To request the RI Board to consider proposing legislation to allow clubs to merge together

WHEREAS, the present bylaws allow only for the creation and dissolution of clubs, there is a reluctance for clubs with declining membership to close, and

WHEREAS, across the world, Rotary membership is static as best, and the present and future administrative costs of both the large number of small clubs and districts is causing concern, and

WHEREAS, there would be much greater support for rationalization of clubs if mergers were allowed where clubs could negotiate to take their name, history and culture into new merged clubs, and

WHEREAS, the health of the Rotary movement would be enhanced significantly if larger and stronger clubs and districts formed the basis of the organization

IT IS RESOLVED by Rotary International that the Board of Directors of Rotary International consider proposed legislation to change the bylaws of Rotary International to allow clubs to merge.

# ADOPTED ENACTMENT 01-130

To clarify the procedures for appeals and arbitration within clubs

IT IS ENACTED by Rotary International that the STANDARD ROTARY CLUB CONSTITUTION be and hereby is amended as follows in article VIII (pages 258-259 MOP)

#### **Article VIII Directors and Officers**

Section 1 – The governing body of this club shall be a board of directors to be constituted as the bylaws of the club may provide.

- Section 2 Except as herein otherwise specifically provided the decision of the board in all club matters shall be final, subject only to an appeal to the club. The board shall have general control over all officers and committees and may, for good cause, declare any office vacant. It shall constitute a board of appeal from the rulings of all officers and actions of all committees. Appeal may be taken from any decision of the board to the club.
- Section 3 Except as herein otherwise specifically provided, the decision of the board in all club matters shall be final, subject only to an appeal to the club. However as to a decision to terminate membership, a member, pursuant to section 7 of article X, may either appeal to the club or request arbitration. On appeal, decisions of the board On such appeal the decision appealed from shall be reversed only by a two-thirds vote of the members present, at a regular meeting specified by the board, a quorum being present, notice of such members of the club at least five (5) days previous to such meeting. If an appeal is taken, the action taken by the club shall be final.
- Section <u>4</u> **3** The officers of this club shall be a president, a president-elect, one or more vice-presidents, all of whom shall be members of the board, and a secretary, a treasurer, and a sergeant-at-arms, any or all of whom may or may not be members of the board as the bylaws of the club shall provide.
- Section <u>5</u>-4
  - .1 Each officer shall be elected as provided in the bylaws of the club and, except as may otherwise be provided in relation to the president, shall take office on the first day of July immediately following election to office and shall serve for the term of office or until a successor shall have been elected and qualified.
  - .2 The president shall be elected, as the bylaws of the club may provide, within the period of not more than two years but not less than eighteen months prior to the day of taking office as president. The president shall be a director of the board and shall serve as president-elect for the year immediately preceding the year in which the term as president shall commence. The president shall take office on the first day of July in the Rotary year for which the president is elected to serve and shall serve for the period of election or until a successor shall have been elected and qualified.
  - .3 Each officer and each director shall be an active (including additional active), senior active, or a past service member in good standing of this club. For a better understanding of the duties and responsibilities of club president, the president-elect shall attend the district presidents-elect training seminar and the district assembly unless excused by the incoming governor. If so excused, the president-elect shall send a designated representative from the club whose duty it will be to report back to the president-elect.

and in article X (page 261 MOP)

#### **Article X Duration of Membership**

**Section 6** — *Termination for Other Causes.* 

- (a) The membership of any member who shall cease to have the qualifications for membership in this club may be terminated by the board by the votes of not less than two-thirds of the members thereof, at a meeting called for that purpose.
- (b) The membership of any member may be terminated by the board, for a reason which the board may deem to be sufficient, by the votes of not less than two-thirds of the members thereof, at a meeting called for that purpose.
- (c) In either case (a) or (b), the member shall be given at least ten (10) days' notice in writing of such pending action and an opportunity to submit to the board a written answer. The member shall also have the privilege of appearing before the board to state the member's case. Service of such notice shall be made by personal delivery or by registered letter to the member's last known address.
- (d) In case of a decision to terminate membership, the secretary shall, within seven days after the date of the board's decision, notify the member in writing of the decision of the board. Such member may, within fourteen days after the date of such notice, give written notice to the secretary of the intention either to appeal to the club or to arbitrate as provided in article XIV of this constitution. In the event of an appeal, the board shall set a date for the hearing of the appeal at a regular meeting of the club, to be held within twenty-one (21) days after the receipt of such written notice of appeal. At least five (5) days' notice of such club meeting and its special business shall be given in writing to every member of the club, and only members of the club shall be permitted to be present when such appeal is considered at such meeting.
- (e) When the board has terminated the membership of an active member as provided for in this section, the club shall not elect a new member under the former classification until the time for hearing the appeal, if any, has expired and the club's decision or the decision of the arbitrators has been announced.
- (f) The action of the board shall be final if no appeal to the club is taken and no arbitration is requested. If an appeal is taken, the action of the club shall be final.
- Section 7 <u>Right to Appeal or Arbitrate Termination.</u>
  - (a) In case of a decision to terminate membership the secretary shall, within seven days after the date of the board's decision, notify the member in writing of the decision of the board. Such member may, within fourteen days after the date of such notice, give written notice to the secretary of the intention either to appeal to the club or to arbitrate as provided in article XIV of the constitution.
  - (b) In the event of an appeal, the board shall set a date for the hearing of the appeal at a regular meting of the club, to be held within twenty-one (21) days after the receipt of such written notice of appeal. At least five (5) days' notice of such club meeting and its special business shall be given in writing to every member of the club, and only members of the club shall be permitted to be present when such appeal is considered at such meeting.
  - (c) In the event of a request for arbitration, each party shall appoint an arbitrator and the arbitrators shall appoint an umpire. Only members of a Rotary club may be appointed as umpire or as arbitrators.
  - (d) If an appeal is taken, the action of the club shall be final and binding on all parties and shall not be subject to arbitration.

- (e) If arbitration is requested, the decision of the arbitrators or, in the event of their disagreement, by the umpire, shall be final and binding on all parties and shall not be subject to appeal.
- Section 8 The action of the board shall be final if no appeal to the club is taken and no arbitration is requested.
- Section <u>9</u>7—*Resignation*. The resignation of any member from the club shall be in writing (addressed to the president or secretary) and shall be accepted by the board, provided that all indebtedness of said member to the club has been paid.
- Section <u>10</u> 8 *Property Interest Forfeiture of*. Any person whose membership in this club has been terminated in any manner shall forfeit all interest in any funds or other property belonging to the club.

and in article XIV (pages 262-263 MOP)

#### **Article XIV Arbitration**

Should any dispute, other than as to a decision of the board, arise between any member or members, or a former member or members, and the club, or any officer or the board of the club, relative to membership or to any alleged breach of the constitution or bylaws, or the expulsion of any member from the club, or on any account whatsoever which cannot be satisfactorily settled under the procedure already provided for such purpose, the matters in difference shall be settled, upon a request to the secretary by any of the disputants, by arbitration. The procedure utilized for such arbitration shall be as provided in sections 7 (c) and (e) of article X. Each party shall appoint an arbitrator and the arbitrators shall appoint an umpire. Only members of a Rotary club may be appointed as umpire or as arbitrators. The decision arrived at by the arbitrators, or, in the event of their disagreement, by the umpire, shall be final and binding on all parties.

# **ADOPTED RESOLUTION 01-133**

To request the RI Board to consider encouraging clubs to present at least one program each Rotary year regarding The Rotary Foundation

WHEREAS, many Rotary clubs do not present programs concerning The Rotary Foundation to their membership, and

WHEREAS, it is important that all Rotarians have the opportunity to learn about the purpose, programs and fund development activities of The Rotary Foundation

IT IS RESOLVED by Rotary International that the Board of Directors of Rotary International consider encouraging all Rotary clubs to present at least one meeting program during each Rotary year on the purpose, programs and fund development activities of The Rotary Foundation.

#### ADOPTED ENACTMENT 01-148

To reduce the types of membership in clubs to active and honorary while retaining the classification principle

IT IS ENACTED by Rotary International that the CONSTITUTION OF ROTARY INTERNATIONAL be and hereby is amended as follows (page 174 MOP)

#### Article V Membership

**Section 3** — *Composition of Clubs.* 

- (a) A club shall be composed of active members who are adult persons of good character and good business and professional reputation,
  - (i) engaged as <u>a</u> proprietor, partner, corporate officer, or manager of any worthy and recognized business or profession, <u>or</u>
  - (ii) holding an important position in any worthy and recognized business or profession or any branch or agency thereof and haveing executive capacity with discretionary authority; or
  - (iii) having retired from any position listed in sub-subsection (i) or (ii) of this subsection

and

having their places of business or residence located within the territorial limits of the club or within the corporate limits of the city in which the club is located or within the territorial limits of an immediately adjoining club, or within an immediately adjoining community not part of the territory of an existing Rotary club. An active member moving from the territorial limits of the club may retain membership in the club where the member's board grants such permission and said active member continues to stay active in the same classification. If a member retires, or a member with three or more years of service changes residence or place of business so that the member no longer meets the foregoing territorial requirements, the club may continue the member's membership without change of classification.

- (b) Each club shall have a well-balanced membership in which no one business or profession predominates. The club shall not elect a person to active membership from a classification if the club already has five or more active members from that classification, unless the club has more than 50 members, in which case, the club may elect a person to active membership in a classification so long as it will not result in the classification making up more than ten percent of the club's active membership. Members who are retired shall not be included in the total number of members from a classification. If a member changes classification notwithstanding these limitations There shall be not more than one active member in each classification of business or profession, excepting the religion, news media, and diplomatic service classifications, and excepting the provision for additional active members as provided in the bylaws.
- (c) The bylaws of RI may provide for kinds of membership in addition to active membership in clubs to be designated as senior active, past service, and honorary

membership and shall prescribe the qualifications for each <u>in addition to active</u> <u>membership in clubs</u>.

- (d) Notwithstanding any other provision of this constitution or of the bylaws of RI or the standard club constitution, a Rotary club may be limited to members of one gender unless such limitation is contrary to the law of the jurisdiction in which the club operates.
- (e) In countries where the word "club" has an inappropriate connotation, Rotary clubs, with the approval of the board, will not be obliged to use it in their names.

IT IS FURTHER ENACTED by Rotary International that the BYLAWS OF ROTARY INTERNATIONAL be and hereby are amended as follows (pages 182-185 MOP)

# **4.010**. *Types of Membership in a Club.*

A club may have four two kinds of membership, active and honorary as stated in the RI constitution.

# 4.020. Active Membership.

A person possessing the qualifications set forth in article V, section 3 of the RI constitution may be elected to active membership in a club. A person possessing the qualifications for active membership, but who is in the same classification of business or profession as an active member of the club, may be elected as an additional member under the provisions of this section. Such additional persons are active members with all the privileges of active membership. However, such additional persons shall not be holders of their classifications and may not propose other additional active members under their own classifications.

#### 4.020.1. Categories of Additional Active Members.

The club may elect three categories of additional active members. A club may have one additional active with the same classification in each of the three categories.

# 4.020.1.1. First Category Same Classification as Proposer.

An active member may propose to active membership a person who is actively engaged in the same classification as that of the proposer.

#### 4.020.1.2. Second Category Former Rotarian.

An active member may propose to active membership a former member of a club, with the consent of the active member holding the classification, if the proposed member terminated such membership in the former club due to no longer being engaged in the formerly assigned classification of business or profession within the territorial limits of the former club.

#### 4.020.1.3. Third Category Former Rotaractor.

An active member may propose to active membership a former member of a Rotaract club, with the consent of the active member who holds the classification. The former Rotaractor must live or work within the territorial limits of the club, have maintained membership in one or more Rotaract clubs for at least four years, and have terminated membership in the former Rotaract club due to reaching the age limit for membership or relocating outside the territorial limits of the former Rotaract club.

#### 4.020.2. Change in Classification Holder.

All additional active members must have the same classification as one of the active members of the club, who is the holder of the classification. If the active member holding the classification ceases to hold the classification for any reason, including a transition to senior active or past service membership, then one of the additional members with the same classification will become the holder of the classification. If there is only one additional active member with such classification, the additional active automatically becomes the classification holder. If there are two or three additional active members with such classification, then the club elects one of them to be the classification holder, and the other member(s) remain as additional actives.

#### 4.030. Senior Active Membership.

#### 4.030.1. General Qualifications.

Any active or past service member shall automatically become a senior active member where such member's combined active and past service membership in one or more clubs includes: a total of at least 15 years membership; a total of at least ten years where the member has attained the age of at least 60 years; a total of at least five years where the member has attained the age of at least 65 years; or, where the member is a present or a past officer of RI.

#### 4.030.2. Former Members.

Any club may elect to senior active membership any former member of any club who was a senior active member or eligible to become a senior active member at the time such membership was terminated.

# 4.030.3. *Rights and Privileges Limitations of Senior Active Membership.* Senior active members shall have all the rights, privileges and responsibilities of an active member, except that they neither hold classifications nor have the right to propose additional active members.

#### 4.030.4. Successor to Senior Active.

A club may admit to membership a qualified person in the classification of business or profession in which such senior active member may be engaged.

#### 4.040. Past Service Membership.

A past service member is one who has all the rights, privileges and responsibilities of an active member except that such a member shall not represent a classification or have the right to propose an additional active member under section 4.020.

#### 4.040.1. Eligibility for Past Service Membership.

The following individuals are eligible for past service membership:

#### 4.040.1.1. Past Service Membership Retirement.

A person who has retired from active business or professional life but who is otherwise qualified for Rotary club membership under article V, section 3, of the RI constitution, including having held a qualifying position level, may be elected a past service member.

#### 4.040.1.2. Past Service Membership Loss of Classification.

Active members who have lost their classifications through no fault of their own may be elected to past service membership by the club board of directors.

#### 4.040.2. Admission Fee Exemption.

Current or former members elected to past service membership in their clubs are exempt from paying a second admission fee.

#### 4.050. 4.030. Dual Membership.

No person shall simultaneously hold active, senior active or past service membership in more than one club. No person shall simultaneously be a member and an honorary member in the same club.

#### 4.060. 4.040. Honorary Membership.

#### 4.060.1. 4.040.1. Eligibility for Honorary Membership.

Persons who have distinguished themselves by meritorious service in the furtherance of Rotary ideals may be elected to honorary membership in more than one club.

#### 4.060.2. <u>4.040.2.</u> Rights and Privileges.

Honorary members shall be exempt from the payment of admission fees and dues, shall have no vote and shall not be eligible to hold any office in the club. Such members shall not hold classifications, but shall be entitled to attend all meetings and enjoy all the other privileges of the club in which they hold such membership. No honorary member of a club is entitled to any rights or privileges in any other club.

#### 4.070. Religion, News Media and Diplomatic Service.

Representatives of more than one religious denomination, representatives of more than one newspaper and/or other news media, and diplomatic services of more than one government may be eligible to active membership under such classifications provided

that such representatives otherwise possess the qualifications as set forth in the constitutional documents.

# 4.080. <u>4.050.</u> Holders of Public Office.

Persons elected or appointed to public office for a specified time shall not be eligible to active membership in a club under the classification of such office. This restriction shall not apply to persons holding positions or offices in schools, colleges or other institutions of learning or to persons who are elected or appointed to the judiciary. Active members who are elected or appointed to public office for a specified period may continue as such active members in their existing classifications during the period in which they hold such office.

# 4.090. <u>4.060.</u> Limitations on Membership.

Notwithstanding the provisions of section 2.030., no club, regardless of the date of its admission to membership in RI, may by provisions in its constitution or otherwise, limit membership in the club on the basis of race, color, creed or national origin or impose any condition of membership not specifically prescribed by the RI constitution or bylaws. Any provision in any club constitution or any condition otherwise imposed in conflict with this section of the bylaws is null, void and without effect.

# 4.100. <u>4.070.</u> RI Employment.

Any club may retain in its membership any member employed by RI.

# 4.110. <u>4.080.</u> Attendance Reports.

Each club shall forward monthly attendance reports of its meetings to the governor within 15 days of the last meeting of each month. Non-districted clubs shall forward such report to the general secretary.

# 4.120. <u>4.090.</u> Attendance at Other Clubs.

Every member shall have the privilege of attending the regular meeting of any other club.

IT IS FURTHER ENACTED by Rotary International that the STANDARD ROTARY CLUB CONSTITUTION be and hereby is amended as follows

in article V (pages 254-256 MOP)

# Article V Membership

- Section 1 *General Qualifications*. This club shall be composed of adult persons of good character and good business or professional reputation.
- **Section 2**—*Kinds*. This Rotary club shall have four two kinds of membership, namely: active, senior active, past service and honorary.
- Section 3 Active Membership.

A person possessing the qualifications set forth in article V, section 3 of the RI constitution may be elected to active membership in this club. A person possessing the qualifications for active membership, but who is in the same classification of business or profession as an active member of this club, may be elected as an additional member under the provisions of this section. Such additional persons are active members with all the privileges of active membership. However, such

additional persons shall not be holders of their classifications and may not propose other additional active members under their own classifications.

- Section 4 *Categories of Additional Active Members.* This club may elect three categories of additional active members. This club may have one additional active with the same classification in each of the three categories.
  - (a) *First Category Same Classification as Proposer.* An active member may propose to active membership a person who is actively engaged in the same classification as that of the proposer.
  - (b) Second Category Former Rotarian. An active member may propose to active membership a former member of a club, with the consent of the active member holding the classification, if the proposed member terminated such membership in the former club due to no longer being engaged in the formerly assigned classification of business or profession within the territorial limits of the former club.
  - (c) Third Category Former Rotaractor. An active member may propose to active membership a former member of a Rotaract club, with the consent of the active member who holds the classification. The former Rotaractor must live or work within the territorial limits of this club, have maintained membership in one or more Rotaract clubs for at least four years, and have terminated membership in the former Rotaract club due to reaching the age limit for membership or relocating outside the territorial limits of the former Rotaract club.
  - (d) Change in Classification Holder. All additional active members must have the same classification as one of the active members of this club, who is the holder of the classification. If the active member holding the classification ceases to hold the classification for any reason, including a transition to senior active or past service membership, then one of the additional members with the same classification will become the holder of the classification. If there is only one additional active member with such classification, the additional active automatically becomes the classification holder. If there are two or three additional active members with such classification, then this club elects one of them to be the classification holder, and the other member(s) remain as additional actives.

#### Section 5 — Senior Active Membership.

- (a) *General Qualifications*. Any active or past service member shall automatically become a senior active member where such member's combined active and past service membership in one or more clubs includes: a total of at least 15 years membership; a total of at least ten years where the member has attained the age of at least 60 years; a total of at least five years where the member has attained the age of at least 65 years; or, where the member is a present or past officer of RI.
- (b) *Former Members.* This club may elect to senior active membership any former member of any club who was a senior active member or eligible to become a senior active member at the time such membership was terminated.
- (c) *Rights and Privileges Limitations of Senior Active Membership.* Senior active members shall have all the rights, privileges and responsibilities of an active member, except that they neither hold classifications nor have the right to propose additional active members.

- (d) *Successor to Senior Active*. This club may admit to membership a qualified person in the classification of business or profession in which such senior active member may be engaged.
- Section 6 Past Service Membership. A past service member is one who has all the rights, privileges and responsibilities of an active member except that such member shall not represent a classification or have the right to propose an additional active member under sections 3 and 4 above.
  - (a) *Eligibility for Past Service Membership.* The following individuals are eligible for past service membership:
    - (i) Past Service Membership Retirement. A person who has retired from active business or professional life but who is otherwise qualified for Rotary club membership under article V, section 3, of the RI constitution, including having held a qualifying position level, may be elected a past service member.
    - (ii) *Past Service Membership Loss of Classification*. Active members who have lost their classifications through no fault of their own may be elected to past service membership by this club's board of directors.
  - (b) *Admission Fee Exemption*. Current or former members elected to past service membership in their clubs are exempt from paying a second admission fee.
- Section 7 <u>4</u> *Dual Membership*. No person shall simultaneously hold active, senior active or past service membership in this and another club. No person shall simultaneously be a member and an honorary member in this club.
- Section 8 <u>5</u> Honorary Membership.
  - (a) *Eligibility for Honorary Membership*. Persons who have distinguished themselves by meritorious service in the furtherance of Rotary ideals may be elected to honorary membership in this club. Persons may hold honorary membership in more than one club.
  - (b) *Rights and Privileges.* Honorary members shall be exempt from the payment of admission fees and dues, shall have no vote and shall not be eligible to hold any office in this club. Such members shall not hold classifications, but shall be entitled to attend all meetings and enjoy all the other privileges of this club. No honorary member of this club is entitled to any rights and privileges in any other club.
- Section 9 *Religion, News Media and Diplomatic Service.* Representatives of more than one religious denomination, representatives of more than one newspaper and/or other news media, and diplomatic representatives of more than one government may be eligible to active membership under such classifications, provided that such representatives otherwise possess the qualifications as set forth in the constitutional documents.
- Section 10 <u>6</u> Holders of Public Office. Persons elected or appointed to public office for a specified time shall not be eligible to active membership in this club under the classification of such office. This restriction shall not apply to persons holding positions or offices in schools, colleges or other institutions of learning or to persons who are elected or appointed to the judiciary. Active members who are elected or appointed to public office for a specified period may continue as such active members in their existing classifications during the period in which they hold such office.
- Section 11 <u>7</u>—*Rotary International Employment*. This club may retain in its membership any member employed by RI.

and in article VI (page 256 MOP)

#### Article VI Classifications

Section 2 — *Limitations*. The club shall not elect a person to active membership from a classification if the club already has five or more active members from that classification, unless the club has more than 50 members, in which case, the club may elect a person to active membership in a classification so long as it will not result in the classification making up more than ten percent of the club's active membership. Members who are retired shall not be included in the total number of members from a classification. If a member changes classification notwithstanding these limitations The active membership shall consist of but one person from each classification of business or profession, excepting the religion, news media, and diplomatic services classifications, which may have more than one person in each such classification, and excepting the provision for additional active members.

and in article VII (page 258 MOP)

#### Article VII Attendance

Section 3 — *Exemptions*. A member's absence shall be excused if

- (a) (i) the absence is caused by protracted ill health or impairment or by stay of more than two weeks in a country in which Rotary clubs do not exist so that such member is physically unable to attend a regular meeting and the board approves such absence.
  - (ii) In the case of intended absence in a country in which there are no Rotary clubs, the member shall inform the secretary of this club before starting the journey or, if that is impossible, in writing from that country. Before approving such absence, the board shall satisfy itself that the journey will prevent the member from making up an absence in accordance with section 1 (a) of this article, or
- (b) a member is a senior active member and the aggregate of the member's years of age and years of membership in one or more clubs is 85 years or more and the member has notified the club secretary in writing of the member's desire to be excused from attendance and the board has approved.

The absences of members who fall into categories (a) (i) and (ii) above and whose absences have been excused shall not be included in the club's attendance records for the period in question. Members who fall into category (b) above shall not be included in the membership figure used to compute the club's attendance; further, neither their absences nor attendances shall be used for that purpose.

and in article VIII (page 259 MOP)

#### Article VIII Directors and Officers Section 4 –

.3 Each officer and each director shall be an active (including additional active), senior active, or a past service member in good standing of this club. For a better understanding of the duties and responsibilities of club

president, the president-elect shall attend the presidents-elect training seminar and the district assembly unless excused by the governor-elect. If so excused, the president-elect shall send a designated representative from the club whose duty it will be to report back to the president-elect.

and in article IX (page 259 MOP)

#### Article IX Admission Fees and Dues

Every active, senior active, and past service member of this club shall pay as an admission fee and as annual dues such sums as may be prescribed in the bylaws of this club, except that a senior active or past service member who has held active membership in this club shall not be required to pay a second admission fee.

and in article X (pages 259-260 MOP)

# Article X Duration of Membership

Section 2 — *How Terminated.* 

- (a) Membership shall automatically terminate when a member ceases to have the necessary qualifications for membership, except that
  - (i) active members who, through no fault of their own, would otherwise lose their classifications may, by action of the board of directors of this club, be elected to past service membership; or
  - (ii) by permission of the board, active members moving from the territorial limits of the club may be given special leave of absence for a period not exceeding one year to enable them to visit and become known to a Rotary club in the community to which they move, providing they are still active in the same classifications of business or profession and continue to comply with the attendance and all other conditions of Rotary membership; or
  - (iii) by permission of the board, active members moving from the territorial limits of the club may retain membership providing they are still active in the same classifications of business or profession and continue to comply with attendance and all other conditions of Rotary membership; or
  - (iii\*) active members who would be losing their classifications without default on their part may retain their classifications and be given special leaves of absence for periods not exceeding one year to enable them to obtain new classifications providing they continue to comply with the attendance and all other conditions of Rotary membership. The termination of their membership would take effect only at the end of the period of leave granted to them.
- (b) When past service members reenter active business or professional life, their memberships automatically become active memberships if the classifications are vacant. If the classifications are not vacant, they continue as past service members.
- (eb) Honorary membership shall automatically terminate on the thirtieth day of June next after the date of election. However, the board in its discretion may, by resolution, from year to year continue such honorary membership for the ensuing year.

and in article XII (page 262 MOP)

#### Article XII Rotary Magazines

**Section 1** — Unless this club is excused by the board of directors of RI from complying with the provisions of this article in accordance with the bylaws of RI, every active, senior active or past service member of this club, by acceptance of such membership, shall become, and so remain for the duration of such membership, a paid subscriber to the official magazine or to the approved magazine prescribed for this club by the board of directors of RI. The subscription shall be handled in six (6) month periods and shall continue for the duration of membership in this club and to the end of any six (6) month period during which membership may cease.

# **Interim Provision**

No one who is a member of a Rotary club as of the effective date of this enactment shall lose membership by reason of the provisions of this enactment.

An active member may propose to active membership a transferring or former member of a club, with the consent of the active member holding the classification, if the proposed member <u>is terminating or has</u> terminated such membership in the former club due to no longer being engaged in the formerly assigned classification of business or profession within the territorial limits of the former club. <u>The transferring or former member of a club being proposed to active membership under this subsection may also be proposed by the former club.</u>

# 4.020.1.3. Third Category — Former Rotaractor.

An active member may propose to active membership a former member of a Rotaract club, with the consent of the active member who holds the classification. The former Rotaractor must live or work within the territorial limits of the club, have maintained membership in one or more Rotaract clubs for at least four years, and have terminated membership in the former Rotaract club due to reaching the age limit for membership or relocating outside the territorial limits of the former Rotaract club.

IT IS FURTHER ENACTED by Rotary International that the STANDARD ROTARY CLUB CONSTITUTION be and hereby is amended as follows

# Article V Membership

IT IS ENACTED by Rotary International that the CONSTITUTION OF ROTARY INTERNATIONAL be and hereby is amended as follows (pages 173-174 MOP)

# Article V Membership

Section 1 — *How Constituted*. The membership of RI shall consist of clubs which continue to perform the obligations as set forth in this constitution and the bylaws.

Section 2 — *Location.* Except as otherwise provided in the bylaws, not more than one club shall be admitted to membership from any one city, borough or municipal area.

Section 3 —*Composition of Clubs.* 

(a) A club shall be composed of active members who are adult persons of good character and good business and professional reputation,

- (i) engaged as a proprietor, partner, corporate officer, or manager of any worthy and recognized business or profession,
- (ii) holding an important position in any worthy and recognized business or profession or any branch or agency thereof and having executive capacity with discretionary authority

and

having their places of business or residence located within the territorial limits of the club and within the corporate limits of the city in which the club is located or within the territorial limits of an immediately adjoining club, or within an immediately adjoining community not part of the territory of an existing Rotary club. An active member moving from the territorial limits of the club may retain membership in the club where the member's board grants such permission and said active member continues to stay active in the same classification.

- (b) There shall be not more than one active member in each classification of business or profession, excepting the religion, news media, and diplomatic service classifications, and excepting the provision for additional active members as provided in the bylaws.
- (c) The bylaws of RI may provide for kinds of membership in addition to active membership in clubs to be designated as senior active, past service, and honorary membership and shall prescribe the qualifications for each.
- (d) Notwithstanding any other provision of this constitution or of the bylaws of RI or the standard Rotary club constitution, a Rotary club may be limited to members of one gender unless such limitation is contrary to the law of the jurisdiction in which the club operates.
- (e) In countries where the word "club" has an inappropriate connotation, Rotary clubs, with the approval of the board, will not be obliged to use it in their names.
- Section 4 *Ratification of Constitution and Bylaws*. Every club granted a certificate of membership in RI and accepting the same thereby accepts, ratifies and agrees to be

bound in all things, not contrary to the law, by this constitution and the bylaws of RI, and amendments thereto, and to faithfully observe the provisions thereof.

Section 5 — *Exceptions*. Notwithstanding any other provision of this constitution or of the bylaws of RI or the standard club constitution, the board, as a pilot project, may admit into membership or permit the reorganization of up to 200 clubs with provisions in their constitutions not in accordance with the RI constitution and bylaws. Such pilot project may extend for a period not exceeding five years. Upon the conclusion of any such pilot project, the constitutions of all clubs admitted into membership or permitted to reorganize shall be the standard club constitution as in effect at that time.

.1 Any member failing to pay dues within thirty (30) days after the prescribed time shall be notified in writing by the secretary at the member's last known address. If the dues are not paid on or before ten (10) days from the date of notification, said membership shall automatically may terminate, subject to the discretion of the board.

IT IS ENACTED by Rotary International that the CONSTITUTION OF ROTARY INTERNATIONAL be and hereby is amended as follows (pages 173-174 MOP)

#### Article V Membership

Section 1 — *How Constituted*. The membership of RI shall consist of clubs which continue to perform the obligations as set forth in this constitution and the bylaws.

Section 2 — *Location*. Except as otherwise provided in the bylaws, not more than one club shall be admitted to membership from any one city, borough or municipal area.

- Section <u>32</u> *Composition of Clubs.* 
  - (a) A club shall be composed of active members who are adult persons of good character and good business and professional reputation,
    - (i) engaged as proprietor, partner, corporate officer, or manager of any worthy and recognized business or profession;
    - (ii) holding an important position in any worthy and recognized business or profession or any branch or agency thereof and having executive capacity with discretionary authority

and

having their places of business or residence located within the territorial limitsin the locality of the club or the surrounding area-within the corporate limits of the eity in which the club is located or within the territorial limits of an immediately adjoining club, or within an immediately adjoining community not part of the territory of an existing Rotary club. An active member moving from the territorial limitslocality of the club or the surrounding area may retain membership in the club where the member's board grants such permission and said active member continues to stay active in the same classification.

- (b) There shall be not more than one active member in each classification of business or profession, excepting the religion, news media, and diplomatic service classifications, and excepting the provision for additional active members as provided in the bylaws.
- (c) The bylaws of RI may provide for kinds of membership in addition to active membership in clubs to be designated as senior active, past service, and honorary membership and shall prescribe the qualifications for each.
- (d) Notwithstanding any other provision of this constitution or of the bylaws of RI or the standard club constitution, a Rotary club may be limited to members of one gender unless such limitation is contrary to the law of the jurisdiction in which the club operates.
- (e) In countries where the word "club" has an inappropriate connotation, Rotary clubs, with the approval of the board, will not be obliged to use it in their names.

Section 43 — *Ratification of Constitution and Bylaws*. Every club granted a certificate of membership in RI and accepting the same thereby accepts, ratifies and agrees to be bound in all things, not contrary to law, by this constitution and the bylaws of RI, and amendments thereto, and to faithfully observe the provisions thereof.

IT IS FURTHER ENACTED by Rotary International that the BYLAWS OF ROTARY INTERNATIONAL be and hereby are amended as follows

# Article II Membership in Rotary International

# 2.020. *Territory*Locality of a Club.

A club may be organized in a <del>clearly definable</del> locality which contains the minimum number of classifications for organizing a new club. <u>A club may be organized in the same</u> <u>locality as one or more existing clubs.</u>

# 2.020.1. Sharing Territory.

The territorial limits of clubs may not overlap except that clubs may have identical territorial limits. A club may be organized with territorial limits identical to one or more existing clubs if the club already possessing the territory, or, if there is more than one elub, a majority of the clubs already sharing the territory so approves. If the clubs whose approval is required number only two, then the majority of the members as provided in subsection 2.020.3. shall be the combined vote of the two clubs.

# 2.020.2. Relinquishing Territory.

A club may be organized in a locality where a majority of the clubs existing in the locality relinquish territory for organizing a new club. A relinquishing club may retain the right to admit members from the relinquished territory.

# 2.020.3. Approval of Sharing or Relinquishing Territory.

A club may relinquish a portion of its territory or share all of its territory as described above pursuant to a majority vote of its members present and voting at any regular meeting. Notice of such proposal to relinquish or share territory must be mailed to the members at least ten days before such meeting. 2.020.4. *Rejection and Reconsideration of Sharing or Relinquishing Territory*. Where a proposal by the governor to form a new club is rejected by the club or one of the clubs holding territory within the locality in which the new club is to be organized, the board of RI may direct at the request of the governor that the matter be reconsidered by the club(s) opposing such organization. The opposing club(s) must confirm their opposition within six weeks of receiving the request by registered mail to reconsider the matter. Such opposition must be confirmed at a weekly meeting which will have been announced to all members of the club by letter sent and postmarked at least 10 days before the meeting, by a two-thirds vote of those members present and voting. The quorum of members who must be present for such vote is half the members plus one. If such quorum is not met, a second meeting shall take place two weeks later and no quorum shall be required. Where the board or governor does not receive such confirmation, the board may approve the sharing or release of such territory. In the event of a second negative vote, the grounds of this vote shall be explained in the confirmation letter addressed by the governor to the board.

#### 2.020.5. Board Authority to Approve Sharing or Relinquishing Territory.

Notwithstanding the provisions of subsection 2.020.4., the board may approve the relinquishment of sharing of territory without the approval of the existing club if, in its opinion, the arguments presented are contrary to the principles of the extension of Rotary and objective conditions exist for the organization of a new club. In making such a request to the board, the governor shall submit a study of the community as well as of the potential recruitment in such territory.

#### 2.020.6. Board Approval for Sharing Territory.

When more than one club has been organized in a clearly definable locality, each with different territories, the board may, upon application of all clubs affected, direct that they shall share the same territory.

#### Article IV Membership in Clubs

#### 4.020. Active Membership.

#### 4.020.1. Categories of Additional Active Members.

The club may elect three categories of additional active members. A club may have one additional active with the same classification in each of the three categories.

#### 4.020.1.1. First Category — Same Classification as Proposer.

An active member may propose to active membership a person who is actively engaged in the same classification as that of the proposer.

#### 4.020.1.2. Second Category — Former Rotarian.

An active member may propose to active membership a former member of a club, with the consent of the active member holding the classification, if the proposed member terminated such membership in the former club due to no longer being engaged in the formerly assigned classification of business or profession within the territorial limits in the locality of the former club or the surrounding area.

# 4.020.1.3. Third Category — Former Rotaractor.

An active member may propose to active membership a former member of a Rotaract club, with the consent of the active member who holds the classification. The former Rotaractor must live or work within the territorial limits in the locality of the club or the surrounding area, have maintained membership in one or more Rotaract clubs for at least four years, and have terminated membership in the former Rotaract club due to reaching the age limit for membership or relocating outside the territorial limits of the former Rotaract club.

# **15.010.** How Established.

The board is authorized to divide group the territory covered by clubs into districts. The president shall promulgate a list of such districts and their boundaries. Such action shall be at the direction of the board. No change shall be made to the boundaries of existing districts over the objection of a majority of the total number of clubs in the district(s) affected, except as otherwise provided hereafter in the bylaws.

Section 1 — *Period*. Membership shall continue during the existence of the club unless terminated as hereinafter provided.

Section 2 — *How Terminated*.

- (a) Membership shall automatically terminate when a member ceases to have the necessary qualifications for membership, except that
  - (i) active members who, through no fault of their own, would otherwise lose their classifications may, by action of the board of directors of this club, be elected to past service membership; or
  - (ii) by permission of the board, active members moving from the territorial limits locality of the club or the surrounding area may be given special leave of absence for a period not exceeding one year to enable them to visit and become known to a Rotary club in the community to which they move, providing they are still active in the same classifications of business or profession and continue to comply with the attendance and all other conditions of Rotary membership; or
  - (iii) by permission of the board, active members moving from the territorial limits locality of the club or the surrounding area may retain membership providing they are still active in the same classifications of business or profession and continue to comply with attendance and all other conditions of Rotary membership; or
  - (iv) active members who would be losing their classifications without default on their part may retain their classifications and be given special leaves of absence for periods not exceeding one year to enable them to obtain new employment in their classifications or in new classifications providing they continue to comply with the attendance and all other conditions of Rotary membership. The termination of their membership would take effect only at the end of the period of leave granted to them.

# Article XVII Amendments

Section 4 — Article I (Name) and Article II (Territorial LimitsLocality of the Club) of this constitution shall be amended at any regular meeting of this club, a quorum being present by the affirmative vote of a majority of members present and voting, provided

that notice of such proposed amendment shall have been mailed to each member at least ten (10) days before such meeting, and provided further, that such amendment shall be submitted to the board of directors of RI for its approval and shall become effective only when so approved. WHEREAS, the Dreams for the Future Committee of RI made many recommendations to "achieve noble objectives by requiring some basic changes in Rotary operations – to move Rotary international into a new level of telecommunication technology – by adopting widespread uses – so as to make the organization much more attractive to younger members –"

IT IS RESOLVED by Rotary International that the Board of Directors of Rotary International consider permitting a pilot project to recognize up to 20 "cyber clubs" which will have innovative and flexible constitutional provisions on membership, attendance, meeting place, admission and territory. Such clubs would be required to participate in all functions typically expected of a Rotary club. Without limiting the generality of these requirements, it is expected that the cyber club would fully participate in:

- a weekly meeting
- service and fellowship activities,
- membership development and extension,
- Rotary Foundation of Rotary International, and
- expectations of involvement in each of the four avenues of service

The Board would canvass relevant Rotary technology interest groups to establish the mechanics for club organizational matters including consideration of such rules as:

• meetings will be conducted by distance communication technology;

- permitting a single meeting to last for not more than seven days;
- limiting the number of members in each "cyber club" to between 20 and 30 members;
- allowing make-ups from members of other cyber clubs; and such others which ensure that the spirit and intent of Rotary membership is observed.

IT IS FURTHER RESOLVED by Rotary International that the Board of Directors of Rotary International, based on the results of the pilot project, consider proposing legislation to the 2004 Council on Legislation to amend constitutional provisions regarding club membership, attendance, meeting place, administration and territory so as to enhance Rotary's ability to attract and retain members.

WHEREAS, it is not evident that these goals are best achieved by following the recommendations given in the *Manual of Procedure* such as having a program of at least two full days, and

WHEREAS, the governor is well informed of the local prerequisites and therefore should be given the full responsibility to plan the district conference by using his knowledge, his skill and his creativity

IT IS RESOLVED by Rotary International that the Board of Directors of Rotary International consider revising the "Twelve Principal Elements of a Good District Conference" in order to allow the governor to adjust the elements of the conference to local circumstances.

Those specifically invited shall include the incoming presidents and <u>the members of clubs</u> <u>assigned by the incoming president to serve in key leadership roles in the upcoming year.</u> <del>secretaries of all clubs in the district, the governor-elect and such others as the board may designate.</del>

#### 15.030. Presidents-elect Training Seminars (PETS).

An annual PETS, which may be a multidistrict PETS, shall take place for the purpose of orientation and training of club presidents-elect in the district as determined by the board. The PETS shall be held <u>annually</u>, preferably in March, within one month after the international assembly. The governor-elect shall be responsible for the PETS. The PETS shall be scheduled planned and conducted by <u>under the direction and supervision of the governor-elect</u>. The governor-elect in cooperation with the governor. The PETS shall not be held at the same time as the district assembly, but the meetings may be held consecutively at the same site where it is not feasible to hold separate events due to distance, weather or cost.

**12.010.** *Nominations for Directors by Zones.* Nominations for directors shall be by zones, as hereinafter provided:

12.010.1. *Number of Zones*. The world shall be divided into 34 zones that are approximately equal in number of Rotarians.

#### 12.010.2. Schedule of Nominations.

Each such zone shall nominate a director from the membership of the clubs in that zone every fourth year according to a schedule established by the board.

12.010.3. *Zone Boundaries*. The initial boundaries of the zones shall be approved by resolution of the council.

## 12.010.4. Periodic Review of Zone Boundaries.

The board shall undertake, no less often than every twelve years, a comprehensive review of the composition of the zones to maintain an approximately equal number of Rotarians in each zone. The board may also undertake, as necessary, interim reviews for the same purpose.

#### 12.010.5. Council Realignment of Zones.

Any new alignments can be made <del>only</del> by the board <del>with the approval by resolution of the council</del>.

#### 12.010.6. Assignment of New Districts.

New districts shall be assigned by the board to an appropriate zone without approval by the council.

#### 12.010.76. Sections Within Zones.

The board may create, modify or eliminate sections in zones in order to rotate in a fair manner the directorship within a zone. These sections shall nominate RI directors on a schedule determined by the board that is based on an approximate equality of number of Rotarians. No such section shall be created, modified or eliminated over the objection of a majority of the clubs in the zone.

#### 12.010.87. Director from Zone in RIBI.

The director from a zone in RIBI shall be nominated by the clubs of that zone either at the annual conference of RIBI or by a postal ballot in such form and at such time as the general council of RIBI shall determine. The name of such nominee shall be certified to the general secretary by the secretary of RIBI.

#### 12.010.98. Interim Provisions Relating to Section 12.010.

#### 12.010.98.1. Implementation of New Zones.

The board is authorized to implement the provisions of section 12.010. as quickly as possible after 1 July 1995.

#### 12.010.98.2. Initial Sections Within Zones.

The initial sections within zones shall be those set forth in an exhibit prepared by the board and distributed at the 1995 council.

#### 12.010.98.3. Nominations of Directors.

Until 30 June 1999, an eligible Rotarian may be suggested to the nominating committee for director in any new zone by a club that is not in that zone but was, prior to the realignment, located in an old zone that has contributed to the makeup of that new zone.

#### 12.010.98.4. Board Authority to Move Districts Within Zones.

Until 30 June 1996, the board may move a district from one new zone to another, when requested by a district resolution adopted by a majority of its clubs, as long as the change preserves the fair and equitable realignment intended by this enactment.

- 6. Honorary members
  - 6.1 shall be exempt from admission fees and dues
  - 6.2 shall have no vote
  - 6.3 shall not be eligible to hold any office in the club
- 7. Honorary members shall be entitled to attend all meetings and enjoy all the other privileges of the club in which they hold such membership.

The governor shall prepare a ballot in the form provided by the board, giving the name of any candidate selected by the district nominating committee. The ballot shall then list in alphabetical order the names of any candidate received by the governor. Where there are more than two candidates, balloting shall be by the single transferable ballot system. The governor shall mail a copy of said ballot to each club with instructions that the completed ballot be returned to and received by the governor. The ballots shall be returned by a date fixed by the governor. Such date shall be no less than 15 days or more than 30 days following the date of the governor's mailing of the ballots to the clubs.

## 13.040.1. Club Voting.

Each club shall be entitled to one vote for each 25 or major fraction thereof of its members. Such membership shall be determined by the number of members in the club as of the most recent semiannual payment preceding that in which the selection is to be made provided the club has no outstanding indebtedness to RI for more than six months preceding that in which the selection is to be made. If a club is entitled to cast more than one vote, the club shall cast all votes for the same candidate.

In such cases, voting shall be restricted to electors. <u>When voting on the selection of the governor-nominee, electors from a club with more than one elector shall cast all votes for the same candidate.</u>

The governor shall also inquire whether any club wishes to concur with the challenge. A club must file a resolution of the club adopted at a regular meeting to concur with any challenge. - (d) planning for the presiding at the district conference and assisting the governorelect in the planning and preparation for the presidents elect training seminar and

district assembly; supporting The Rotary Foundation with respect to program participation and financial contributions;

- (e) personally visiting every club as early in the year as possible, but preferably during the first six months; promoting cordial relations among the clubs and between the clubs and RI;
- (f) issuing a monthly letter to each club president and secretary in the district; planning for and presiding at the district conference and assisting the governorelect in the planning and preparation for the presidents-elect training seminar and the district assembly;
- (g) reporting promptly to RI as may be required by the president or the board; providing for an official meeting individually or in multi-club meetings conducted throughout the year to take place at a time that maximizes the governor's presence for the purpose of:

focusing attention on important Rotary issues;
 providing special attention to weak and struggling clubs;
 motivating Rotarians to participate in service activities; and
 personally recognizing the outstanding contributions of Rotarians in the district;

- (h) supplying the governor elect, prior to the international assembly, full information as to the condition of clubs with recommended action for strengthening clubs; issuing a monthly letter to each club president and secretary in the district;
- (i) transferring continuing district files to the governor-elect; and reporting promptly to RI as may be required by the president or the board;
- (j) <u>performing such other duties as are inherent as the officer of RI; supplying the</u> governor-elect, prior to the international assembly, full information as to the condition of clubs with recommended action for strengthening clubs;
- (k) assuring that district nominations and elections are conducted in accordance with this constitution and the bylaws and the established policies of RI;
- (1) transferring continuing district files to the governor-elect; and

(m) performing such other duties as are inherent as the officer of RI.

The terms of reference of the nominating committee, including the degree of application of this resolution, shall be determined in a resolution adopted by the electors of the clubs present and voting at a district conference.

Such review should be structured in accordance with the announced selection criteria.

When the governor notifies all clubs of the name of any challenging nomination, and in order to facilitate judgment by the clubs, the governor should also add a comprehensive review of the challenging candidate's personal data, qualifications and relevant experience. Such review should be structured in accordance with the announced selection criteria.

- .1 Any proposal to amend this constitution shall be delivered to the general secretary not later than 30 June in the year preceding that in which the council on legislation is to meet.
- .2 The general secretary of RI shall mail five ten copies of all duly proposed amendments to each governor, one copy to all members of the council on legislation and one copy to the secretary of any club that requests it, not later than 31 December in the year the council shall be convened. The proposed amendments also will be made available via the Rotary world wide web home page. Resumés of all proposed amendments, with details of the deletions and additions omitted, shall be sent to each club.
- .3 The council shall consider and act upon each duly proposed amendment transmitted to the council and any amendment thereof.

#### Article I Definitions

As used in this constitution, unless the context otherwise clearly requires, the words in this article shall have the following meanings:

- 1) Board: The Board of Directors of this club.
- 2) Bylaws: The bylaws of this club.

3) Director: A member of this club's Board of Directors.

4) Member: A member, other than honorary, of this club.

5) RI: Rotary International.

6) Year: The twelve-month period which begins on 1 July.

## Article I II Name

## Article H III Territorial Limits

The territorial limits of this club are as follows:

## Article III IV Object

The Object of Rotary is to encourage and foster the ideal of service as a basis of worthy enterprise and, in particular, to encourage and foster:

First. The development of acquaintance as an opportunity for service;

*Second.* High ethical standards in business and professions; the recognition of the worthiness of all useful occupations; and the dignifying of each Rotarian's occupation as an opportunity to serve society;

*Third*. The application of the ideal of service in each Rotarian's personal, business and community life;

*Fourth*. The advancement of international understanding, goodwill, and peace through a world fellowship of business and professional persons united in the ideal of service.

<sup>\*</sup> The bylaws of Rotary International provide that each club admitted to membership in RI shall adopt this prescribed standard club constitution.

## Article IV V Meetings

Section 1 – <u>Regular Meetings.</u>

- (a).1 <u>Day and Time</u>. This club shall hold a regular meeting once each week on the day and at the time provided in its the bylaws.
- (b).2 <u>Change of Meeting</u>. In an emergency or for For good cause, the board of directors of this club-may change a regular meeting to any day during the period commencing with the day following the preceding regular meeting and ending with the day preceding the next regular meeting, or to a different hour of the regular day, or to a different place.
- (c).3 <u>Cancellation</u>. If a regular meeting The board may cancel a regular meeting if it falls on a legal holiday or in the case of the death of the club president, or of an epidemic or of a disaster affecting the whole community, the board may cancel such regular meeting. The board of directors of this club, at its discretion, may cancel not more than two regular meetings in any one Rotary a year for causes not otherwise specified herein provided always that the this club should does not fail to meet for more than two consecutive meetings.

Section 2 – <u>Annual Meeting</u>. An annual meeting for the election of officers of this club shall be held not later than the thirty-first day of <u>31</u> December in each year as provided in the bylaws of this club.

# Article **V**<u>VI</u> Membership

- Section 1 *General Qualifications*. This club shall be composed of adult persons of good character and good business <del>or</del>and professional reputation.
- Section 2 *Kinds*. This Rotary club shall have four kinds of membership, namely: active, senior active, past service and honorary.
- Section 3 Active Membership. A person possessing the qualifications set forth in article V, section 3 of the RI constitution may be elected to active membership in this club. A person possessing the qualifications for active membership, but who is in the same classification of business or profession as an active member of this club, may be elected as an additional member under the provisions of this section. Such additional persons are active members with all the privileges of active membership. However, such additional persons shall not be holders of their classifications and may not propose other additional active members under their own classifications.
- Section 4 -- Categories of Additional Active Members. This club may elect three categories of additional active members. This club may have one additional active with the same classification in each of the three categories.
  - (a) *First Category -- Same Classification as Proposer.* An active member may propose to active membership a person who is actively engaged in the same classification as that of the proposer.
  - b) *Second Category -- Former Rotarian.* An active member may propose to active membership a former member of a club, with the consent of the active member holding the classification, if the proposed member terminated such membership in the former club due to no longer being engaged in the formerly assigned classification of business or profession within the territorial limits of the former club.
  - (c) *Third Category -- Former Rotaractor*. An active member may propose to active membership a former member of a Rotaract club, with the consent of the active

member who holds the classification. The former Rotaractor must live or work within the territorial limits of this club, have maintained membership in one or more Rotaract clubs for at least four years, and have terminated membership in the former Rotaract club due to reaching the age limit for membership or relocating outside the territorial limits of the former Rotaract club.

(d) Change in Classification Holder. All additional active members must have the same classification as one of the active members of this club, who is the holder of the classification. If the active member holding the classification ceases to hold the classification for any reason, including a transition to senior active or past service membership, then one of the additional members with the same classification will become the holder of the classification. If there is only one additional active member with such classification, the additional active automatically becomes the classification holder. If there are two or three additional active members with such classification, then this club elects one of them to be the classification holder, and the other member(s) remain as additional actives.

#### Section 5 – Senior Active Membership.

- (a) *General Qualifications*. Any active or past service member shall automatically become a senior active member where such member's combined active and past service membership in one or more clubs includes: a total of at least 15 years membership; a total of at least ten years where the member has attained the age of at least 60 years; a total of at least five years where the member has attained the age of at least 65 years; or, where the member is a present or past officer of RI.
- (b) *Former Members*. This club may elect to senior active membership any former member of any club who was a senior active member or eligible to become a senior active member at the time such membership was terminated.
- (c) *Rights and Privileges -- Limitations of Senior Active Membership.* Senior active members have all the rights, privileges and responsibilities of an active member, except that they neither hold classifications nor have the right to propose additional active members.
- (d) *Successor to Senior Active*. This club shall admit to membership a qualified person in the classification of business or profession in which such senior active member may be engaged.
- Section 6 *Past Service Membership.* A past service member is one who has all the rights, privileges and responsibilities of an active member except that such member shall not represent a classification or have the right to propose an additional active member under sections 3 and 4 above.
  - (a) *Eligibility for Past Service Membership*. The following individuals are eligible for past service membership:
    - (i) Past Service Membership -- Retirement. A person who has retired from active business or professional life but who is otherwise qualified for Rotary club membership under article V, section 3, of the RI constitution, including having held a qualifying position level, may be elected a past service member.
    - (ii) Past Service Membership -- Loss of Classification. Active members who have lost their classifications through no fault of their own may be elected to past service membership by this club's board of directors.

- (b) *Admission Fee Exemption.* Current or former members elected to past service membership in their clubs are exempt from paying a second admission fee.
- Section 7 *Dual Membership*. No person shall simultaneously hold active, senior active or past service membership in this and another club. No person shall simultaneously be a member and an honorary member in this club.

**Section 8** – *Honorary Membership.* 

- (a) *Eligibility for Honorary Membership.* Persons who have distinguished themselves by meritorious service in the furtherance of Rotary ideals may be elected to honorary membership in this club. Persons may hold honorary membership in more than one club.
- (b) *Rights and Privileges.* Honorary members shall be exempt from the payment of admission fees and dues, shall have no vote and shall not be eligible to hold any office in this club. Such members shall not hold classifications, but shall be entitled to attend all meetings and enjoy all the other privileges of this club. No honorary member of this club is entitled to any rights and privileges in any other club.
- Section 9 Religion, News Media and Diplomatic Service. Representatives of more than one religious denomination, representatives of more than one newspaper and/or other news media, and diplomatic representatives of more than one government may be eligible to active membership under such classifications, provided that such representatives otherwise possess the qualifications as set forth in the constitutional documents.
- Section 10 Holders of Public Office. Persons elected or appointed to public office for a specified time shall not be eligible to active membership in this club under the classification of such office. This restriction shall not apply to persons holding positions or offices in schools, colleges or other institutions of learning or to persons who are elected or appointed to the judiciary. Active members who are elected or appointed to public office for a specified period may continue as such active members in their existing classifications during the period in which they hold such office.
- Section 11 *Rotary International Employment*. This club may retain in its membership any member employed by RI.

# Article <del>VI</del> <u>VII</u> Classifications

Section 1 - Classifications General Provisions.

- (a) <u>*Principal Activity.*</u> Each active member of this club shall be classified in accordance with the member's business or profession.
- (b) The classification of each active member of this club-shall be that which covers describes the principal and recognized activity of the firm, company or institution with which such the member is connected or that which covers such describes the member's principal and recognized business or professional activity.

If the circumstances warrant, T-the board, in its discretion, may correct or adjust the classification of any member whose membership has not terminated, if the circumstances warrant such action. Due n Notice of such a proposed correction or adjustment shall be given provided to the member and the member shall be allowed a hearing thereon.
- Section 2 Limitations. Except for additional active members and as provided in section 9 of article VI, T-the active membership shall consist of but only one person member from each classification of business or profession, excepting the religion,

news media, and diplomatic services classifications, which may have more than one person in each such classification, and excepting the provision for additional active members.

    - (3)(iii)-attends a convention of RI, a council on legislation, an international assembly, a Rotary institute for past and present officers of RI, a Rotary institute for past, present and incoming officers of RI, or any other meeting convened with the approval of the board <u>of directors of RI</u>, or the president <u>of RI</u> acting for <u>on behalf of</u> the board of <u>directors of RI</u>, a Rotary multizone conference, a <u>RI committee meeting</u>, <u>meeting of a</u> <u>committee of RI</u>, a Rotary district conference, a Rotary district assembly, any district meeting held by direction of the board of directors of RI, any district committee meeting held by direction of the district governor, or a regularly announced intercity meeting of Rotary clubs; or
    - (4)(iv) is present at the usual time and place of a regular meeting of another club for the purpose of attending such meeting, and <u>but</u> that club is not meeting at the <u>that</u> time and <u>or</u> place, ;or
      - (v) except that where a member is traveling outside the member's country of residence for a period exceeding fourteen days, the time restriction shall not be imposed by this subsection inasmuch as a member may attend meetings in another country at any time during the period of travel, and each such attendance shall count as a valid make up for any regular meeting missed at this club during the member's time abroad, or
    - (5)(vi) attends a club service project authorized by the board of this club.

When a member is outside the member's country of residence for more than fourteen (14) days, the time restriction shall not be imposed so that the member may attend meetings in another country at any time during the travel period, and each such attendance shall count as a valid make-up for any regular meeting missed during the member's time abroad.

- (6)(vi) engaged in Rotary business duly authorized by the board of this club if this which precludes attendance at the meeting. a meeting of this club, or
- (c)(vii) <u>Extended Absence on Outposted Assignment</u>. - Section 2 Notice of Make-up. In the cases set out in subparagraphs Under the provisions of sub-subsection (a) (i)(1)and or subsubsection (a) (iv)(4) of section 1 of this article, such notice may be given by the member personally or by the secretary of the club visited. Under the provisions of subsection (c) of section 1 of this article, such notice must be given by the secretary of the club visited.
- Section 3 *Exemptions*. *Excused Absences*. With the board's permission, A a member's absence shall be excused if
  - (a) (i) the absence is caused by protracted ill health or impairment, or; or by stay of more than two weeks in a country in which Rotary clubs do not exist so that such member is physically unable to attend a regular meeting and the board approves such absence.
  - (b) (ii) In the case of intended absence for more than two weeks, the member is in a country in which there are no Rotary clubs, and the member shall so informs the secretary of this club before starting the journey or, if that is impossible, notifies the secretary in writing from that the country. Before approving such absence, the board shall satisfy itself determine that the journey will prevent the member from making up an absence in accordance with subsection section 1 (a) of section 1 of this article; or a the member is a senior active member and the whose aggregate of the member's years of age and years of membership in one or more clubs is

- Section 4 *RI Officers' Absences*. A member's absence shall be excused if the member is a current officer of RI.

Any Members who fall into whose absences are excused under the provisions of subsection (c) of section 3 of this article category (b) above shall not be included in the membership figure used to compute the this club's attendance; further, neither nor shall their such absences nor attendances shall be used for that purpose.

# Article VIII IX Directors and Officers

- Section 1 <u>Governing Body</u>. The governing body of this club shall be a <u>the</u> board of <u>directors to be</u> constituted as the bylaws of the club may provide.

- Section 3 <u>Officers</u>. The <u>club</u> officers <del>of this club</del> shall be a president, a presidentelect, <u>and</u> one or more vice-presidents, all of whom shall be members of the board, and a secretary, a treasurer, and a sergeant-at-arms, <del>any or all of whom</del> <u>who</u> may or may not be members of the board as the bylaws <del>of the club shall</del> provide.
- Section 4 <u>Election of Officers.</u>
  - .1(a) <u>Term of Officers other than President</u>. with the <u>meet</u> attendance and all other conditions of Rotary <u>club</u> membership. The t<u>T</u>ermination of their membership would take effect only at the end of the period of leave granted to them the member.

- (b) *How to Rejoin.* When the membership of an active member has terminated as provided in subsection (a) of this section, such person may make new application for membership, under the same or another classification. A second admission fee shall not be required,
- (b) When past service members reenter active business or professional life, their memberships automatically become active memberships if the classifications are vacant. If the classifications are not vacant, they continue as past service members.
- (c) Honorary membership shall automatically terminate on the thirtieth day of <u>30</u> June next after following the date of election. However, <u>on an annual basis</u>, the board in its discretion may, by resolution, from year to year continue such extend <u>an</u> honorary membership for the ensuing <u>an additional year</u>.
- Section 3 -- How to Rejoin. When the membership of an active member has terminated as provided in the foregoing section 2, such person may make new application for membership, under the same classification or another classification. If elected to membership, a second admission fee shall not be required.
- **Section 4–<u>3</u>** *Termination -- Non-Payment of Dues.* 
  - .1 (a) Any member failing to pay dues within thirty (30) days after the prescribed time shall be notified in writing by the secretary at the member's last known address. If the dues are not paid on or before ten (10) days from of the date of notification, said membership shall automatically terminate.
  - .2 (b) Such former member, at the discretion of the <u>The</u> board, may be reinstated <u>the former member</u> to membership upon the former member's petition, and upon the payment of all indebtedness to the club, <u>provided that However</u>, no former member can <u>may</u> be reinstated to active membership if the <u>former</u> <u>member's</u> classification of the former member has been filled.

**Section 5**-4 - *Termination -- Non-Attendance*.

- (a) <u>Attendance Percentages.</u> Each <u>A</u> member, other than an honorary member of this club, must
  - attend or make up at least 60% percent of club regular meetings in each half of the Rotary year;
  - (2) attend at least 30% percent of the <u>this club's</u> regular meetings of this club in each half of the <del>Rotary</del> year.

If such a member fails to attend as required above, that person's the member's membership shall automatically terminate unless the board consents to such non-attendance for good <u>cause</u>. and sufficient reason. If such member is a current officer of RI, that member shall be excused from attending the regular meetings of such member's club until the member's current term of office expires.

(b) <u>Consecutive Absences.</u> The membership of any member, other than an honorary member, of this club shall automatically terminate if, without the consent of the board for good and sufficient reason, the member fails to attend or make up four consecutive club regular meetings- unless such member is excused pursuant to article VIII, section 4, or is otherwise excused by the board for good and sufficient reason.

#### **Section 65** – *Termination for* – Other Causes.

- (a) <u>Good Cause</u>. The <u>board may terminate the</u> membership of any member who <u>shall</u> ceases to have the qualifications for membership in this club <u>or for any good cause</u> may be terminated by the board by the <u>a</u> votes of not less than two-thirds of the members thereof, at a meeting called for that purpose.
- (b) The membership of any member may be terminated by the board, for a reason which the board may deem to be sufficient, by the votes of not less than two-thirds of the members thereof, at a meeting called for that purpose.
- (eb) <u>Notice.</u> In either case (a) or (b), the Prior to taking any action under subsection (a) of this section, the member shall be given at least ten (10) days' written notice in writing of such pending action and an opportunity to submit a written answer to the board a written answer. The member shall also have the privilege of appearing right to appear before the board to state the member's case. Service of such notice Notice shall be made by personal delivery or by registered letter to the member's last known address.
- (dc) <u>Appeal or Arbitration.</u> In case of a decision to terminate membership, the secretary shall, within Within seven (7) days after the date of the board's decision to terminate membership, the secretary shall give written notice of the decision to, notify the member. in writing of the decision of the board. Such member may, within Within fourteen (14) days after the date of such the notice, the member may give written notice to the secretary of the intention either to appeal to the club or to arbitrate as provided in article XV XIV of this constitution. In the event of an appeal, the board shall set a date for the hearing of the appeal at a regular club meeting of the club, to be held within twenty-one (21) days after the receipt of the such written notice of appeal. At least five (5) days' written notice of such club the meeting and its special business shall be given in writing to every member. of the club, and only Only members of the club shall be permitted to be present when such the appeal is heard considered at such meeting.
- (ed) <u>Filling Classification</u>. When the board has terminated the membership of an active member as provided for in this section, the this club shall not elect a new member under the former member's classification until the time for hearing the any appeal, if any, has expired and the elub's decision of the club or the decision of the arbitrators has been announced.
- (fe) <u>Board Action Final.</u> The <u>Board</u> action of the board shall be final if no appeal to the this club is taken and no arbitration is requested. If an appeal is taken, the action of the this club shall be final.
- Section 76 Resignation. The resignation of any member from the this club shall be in writing, (addressed to the president or secretary) and The resignation shall be accepted by the board, provided that all indebtedness of if said the member has no indebtedness to the this club has been paid.
- Section 87 <u>Forfeiture of Property Interest</u> <u>Forfeiture of</u>. Any person whose <u>club</u> membership in this club has been terminated in any manner shall forfeit all interest in any funds or other property belonging to the <u>this</u> club.

# Article XI XII Community, National and International Affairs

Section 1 -- <u>Proper Subjects</u>. The general welfare of the community, the nation and the world is a concern to the members of this club, and the <u>The</u> merits of any public question involving the general welfare of the community, the nation and the world are

of concern to the members of this club and such welfare shall be proper subjects of fair and intelligent informed study and discussion before at a club meeting for the enlightenment of its members in forming their individual opinions. However, this club shall not express an opinion on any pending controversial public measure.

- Section 2 <u>No Endorsements</u>. This club shall not endorse or recommend any candidate for public office and shall not discuss at any club meeting the merits or demerits of any such candidate.
- Section 3 <u>Non-Political.</u>
  - (a) <u>Resolutions and Opinions.</u> This club shall neither adopt nor circulate resolutions or views opinions, nor and shall not take corporate action dealing with world affairs or international policies of a political nature.
  - (b) <u>Appeals.</u> This club shall not direct appeals to clubs, peoples or governments, or circulate letters, speeches, or proposed plans for the solution of specific international problems of a political nature.

Section 4 – Recognizing Rotary's Beginning.

The week of the anniversary of Rotary's founding (23 February) shall be known as World Understanding and Peace Week. During this week, this club will celebrate Rotary service, reflect upon past achievements and focus on programs of peace, understanding and goodwill in the community and throughout the world.

- .1 This club will strive to emphasize aspects of Rotary service during a special week of celebrations commencing on the anniversary of Rotary's establishment. The week commencing on 23 February of each year shall be known as World Understanding and Peace Week.
- .2 While the special week will provide opportunity to reflect upon past achievements, it is appropriate to focus upon programs of peace, understanding and goodwill within the community and throughout the world.

# Article XII XIII Rotary Magazines

- Section 1 <u>Mandatory Subscription</u>. Unless, in accordance with the bylaws of RI, this club is excused by the board of directors of RI from complying with the provisions of this article in accordance with the bylaws of RI, every each active, senior active or and past service member shall, of this club, by acceptance of such membership, shall become, and so remain for the duration of such membership, a paid subscriber subscribe to the official magazine or to the approved magazine approved and prescribed for this club by the board of directors of RI. The subscription shall be handled paid in six (6) month periods and shall continue for the duration of membership in this club and to the end of any six (6) month period during which membership may terminate cease.
- Section 2 <u>Subscription Collection</u>. The <u>subscription</u> amount of the subscription shall be collected by the <u>this</u> club from each member semiannually in advance and remitted to the Secretariat of RI or to the office of such regional publications as may be determined by the board of directors of RI.

# Article XIII XIV Acceptance of Object and Compliance with Constitution and Bylaws

By payment of an admission fee and dues, A a member, by payment of an admission fee and dues, thereby accepts the principles of Rotary as expressed in its object and submits

to and agrees to comply with and be bound by the constitution and bylaws of this club, and on those conditions alone is entitled to the privileges of this club. <del>No member shall be absolved from the observance</del> <u>Each member shall be subject to the terms</u> of the constitution and bylaws <del>on the plea that such member has not received a copy of them.</del> <u>regardless of whether such member has received copies of them.</u>

#### Article XIV XV Arbitration

Should any dispute arise between any <u>current</u> member or members, or a former member(s) or members, and the <u>this</u> club, or any <u>club</u> officer or the board of the club, relative to membership or to any alleged breach of the constitution or bylaws, or the expulsion of any member from the <u>this</u> club, or on any account whatsoever which cannot be satisfactorily settled under the procedure already provided for such purpose, the matters in difference dispute shall be settled by arbitration. Each party shall appoint an arbitrator and the arbitrators shall appoint an umpire. Only <u>a</u> members of a Rotary club may be appointed as umpire or as arbitrators. The decision <u>reached</u> arrived at by the arbitrators, or, <u>if they disagree</u> in the event of their disagreement, by the umpire, shall be final and binding on all parties.

#### Article XV XVI Bylaws

This club shall adopt bylaws not inconsistent with the constitution and bylaws of RI<u></u> (and the rules of procedure for an area administration where established) with the rules of procedure for an administrative territorial unit where established by RI, and with this constitution, embodying additional provisions for the government of this club. Such bylaws may be amended from time to time as therein provided.

#### Article XVI Interpretation

Throughout this constitution, pronouns of either the masculine or feminine gender shall include the other.

#### Article XVII Amendments

- Section 1 *Time<u>Manner of Amending</u>*. Except as provided in section-4-2 of this article, this constitution may be amended only by the council on legislation in the same manner as is established in the bylaws of RI for the amendment of its bylaws.
- Section 2 --- Who May Propose. Amendments to this constitution, except as provided in section 4 of this article, may be proposed only by a club, by a district conference, by the general council or the conference of RI in Great Britain and Ireland, by the council on legislation, or by the board of directors of RI.

Section 3 -- Procedure.

- .1 Any proposal to amend this constitution shall be delivered to the general secretary of RI not later than 30 June in the year preceding that in which the council on legislation is to meet.
- .2 The general secretary of RI shall mail five copies of all duly proposed amendments to each governor, one copy to all members of the council on legislation and one copy to the secretary of each club that requests it, no later than 31 December in the year the council shall be convened. The proposed amendments also will be made available via the Rotary World Wide Web home page. Résumés of all proposed enactments, with details

of the deletions and additions to the *Manual of Procedure* omitted, shall be sent to each club.

- .3 The council shall consider and act upon each duly proposed amendment transmitted to the council and any duly proffered amendment thereof.
- Section-4-2 <u>Amending Article II and Article III.</u> Article I<u>I</u> (Name) and Article II<u>I</u> (Territorial Limits) of this the constitution shall be amended at any regular meeting of this club, a quorum being present by the affirmative vote of a majority of members present and voting, provided that notice of such proposed amendment shall have been mailed to each member at least ten (10) days before such meeting, and provided further, that such amendment shall be submitted to the board of directors of RI for its approval and shall become effective only when so approved. In the event of reconsideration of a decision not to relinquish or share territory for the organization of an additional club, as directed by the board of directors of RI, as provided in subsection 2.020.4. of the bylaws of RI<sub>2</sub> a two-thirds vote is required to sustain the previous negative decision.

To allow regular meetings to be cancelled due to armed conflicts

IT IS ENACTED by Rotary International that the STANDARD ROTARY CLUB CONSTITUTION be and hereby is amended as follows (page 253 MOP)

#### Article IV Meetings Section 1 —

.3 If a regular meeting falls on a legal holiday or in case of the death of the club president, or of an epidemic or of a disaster affecting the whole community, or of an armed conflict in the community which endangers the lives of the members of the club, the board may cancel such regular meeting. The board of directors of this club, at its discretion, may cancel not more than two regular meetings in any one Rotary year for causes not otherwise specified herein provided always that the club should not fail to meet for more than two consecutive meetings.

To encourage members and guests to refrain from smoking at meetings and events held in the name of Rotary

## Article II Membership in Rotary International

2.040. Smoking.

In recognition of the deleterious effect upon personal health, individual members and their guests are encouraged to refrain from smoking during meetings and other events organized in the name of Rotary International.

The board may terminate the membership of any club where such club disbands for any reason, fails to meet regularly or otherwise fails to function. <u>Before acting on a</u> termination for failure to function, the board shall request the governor to submit a report regarding the circumstances of the termination.
